#### **Financial Information:**

DISLF's year ended 9/30/2023 with Total Checking of \$789,564.10. The Community Foundation of South Alabama had the DISLF Fund at \$2,359,731.91 and the George Crozier Fund at \$248,332.77, for total assets of \$2,608,064.60

#### Goals for FY2023:

Fundraising goals were established at the beginning of the fiscal year. These goals were based on a three-year rolling average of the DISLF donors, gifts and dollars.

#### **Cocktails with the Critters:**

The Virtual Auction was held April 26, 2023 – May 3, 2023. The date for the in-person event was May 4, 2023. Cause 4 Auction did away with their auction site, so Foundation staff researched several months and talked to several auction companies for a new site. The Auction site Betterworld was chosen and used for this year's online auction. Everything went great with the site.

Sponsors: 422 Corporate sponsor letters were mailed on Nov 7, 2022, and 413 on Jan 16, 2023. The number of corporate sponsors was 62. The number of individual sponsors was 14.

Silent Auction: This year's auction generated a gross revenue of \$19,914 from 141 items with a FMV of \$61,685.00.

Foundation staff uploaded pictures and descriptions of all the Auction items to Betterworld. Betterworld was very user-friendly with excellent reporting. We had a total of 63 Bidders sign up for the Auction. The ability to sign up for the auction ahead of time however was not offered. Once the Auction live the Bidders could register. A formula was used to determine starting bids (40% FMV) and bid increases were uniform based on the item's value. We had 2 trips that did not sell.
