DISLF's year ended 9/30/2025 with Total Checking of \$1,213,835.44. The Community Foundation of South Alabama had the DISLF Fund at \$3,140,612.70 and the George Crozier Fund at \$295,305.03, for total assets of \$4,653,683.82.

The Foundation has two funds at the CFSA; The George Crozier Endowment Fund which was established with a matching grant from the Kresge Foundation, which is governed by the restrictive rules, established by Kresge. The second fund is the DISLF Endowment Fund, which has been funded through the fundraising efforts of the Foundation and is a donor directed fund. The DISLF Fund ending 9/30/2025 was \$3,140,612.70 and the Crozier Fund balance ending 9/30/2025 was \$295,305.03 for a total of \$3,435,917.73.

Marine Environmental Awards Luncheon (MEAL) 2024

The 12th Annual Environmental Awards Luncheon was held on Wednesday, October 30, 2024 at the Battle House Hotel. The event was a wonderful success with 325 Reservations with 38 Tables. This year Oakworth Bank was \$5,000 Sponsor. Keynote Speaker: Dr. Larry Madin Director Emeritus and Senior Science Advisor at Woods Hole Institute. Silent Auction: This year's auction generated a gross revenue of \$16,890.83 from 130 items with a FMV of \$64,000.00.

Foundation staff uploaded pictures and descriptions of all the Auction items to Betterworld. Betterworld was very user-friendly with excellent reporting. We had a total of 54 Bidders sign up for the Auction. The ability to sign up for the auction ahead of time however was not offered. Once the Auction live the Bidders could register. A formula was used to determine starting bids (40% FMV) and bid increases were uniform based on the item's value. We had 6 trips that did not sell.
